MESSAGE FROM THE DIRECTOR

Greetings,

The year 2023 was a monumental one in our organizational development. We were able to launch new family resource programming in Buffalo and Pepin Counties and collaborated with school districts in those counties to provide homeless navigation services. We are excited to offer parent education seminars and events to build relationships with families and caregivers in these communities.

Although childcare continues to be challenging to find in Western Wisconsin, our dedicated staff worked diligently to offer Resource & Referral services to parents helping them find and evaluate childcare options for their families. Over this year, creative solutions were needed to meet the needs of rural families and family, friend, and neighbor care became key to lessening this barrier. We were able to refer them to our start-up services for support. Our desire for children to have experiences that help them to grow and develop strengthens our commitment to support early learning professionals with quality training and consulting on best practices. Building childcare capacity in rural communities has been the focus of our work this year offering recruitment sessions, entry-level training, and pre-licensing services to start new childcare businesses.

One of the highlights of the year was working with various communities on Dream Up Taskforce goals to assist communities in coming together to plan for supporting existing and recruiting new childcare programs to build capacity. Staff had many opportunities to educate community members and local legislators about how affordable, accessible childcare provides vital support for working families, employers, and our state economy. Local communities found our staff's ability to start mentorship programs, support local networks, offer start-up sessions, entry-level training, and pre-licensing services to start new businesses to be invaluable.

It was exciting to see our Business Child Care Advocate educate businesses and community members on family-friendly policies and facilitate participation in the Partner Up program connecting businesses with childcare programs for employees. A new awareness was built around the importance of accessible affordable childcare and attracting and retaining quality, reliable employees.

Data is a big part of our work as a Resource & Referral agency and this year CCP (Child Care Partnership) staff was integral in disseminating a statewide capacity survey, compiling, and reporting results to the Department of Children and Families and local legislators. Advocacy on the teacher shortage, closed classrooms, and other childcare desert issues continue to be forefront of our work to be sure that parents can go to work without worry knowing that their children have safe, healthy quality environments to learn, play, and thrive.

As CCP moves forward, we continue to keep the needs of young children and their families the focus of our work.

CCR&R

Child Care Resource & Referral staff provides referrals to child care programs for families seeking child care, provides technical assistance to families, provides training & technical assistance to child care programs, and works throughout our service delivery area in the communities we serve attending meetings, work groups & advocating for early childhood professionals.

Child Care Financial Assistance

The Child Care BRIDGE fund assists low-income families with past-due child care balances to assist with the financial stability of the family while also helping stabilize the revenue of child care programs.

PreLicensing

PreLicensing services are for potential family child care and group child care providers who are working towards becoming licensed facilities. Staff also reguarly holds outreach sessions to share information to individuals interested in entering the child care workforce.

Pepin County Certification

CCP providers certification services for individuals who are interested in providing care for children in their own home in Pepin County. Certified providers can care for up to 3 children under the age of 7 who are not related (to the provider) with a maximum group size of 6.

DWD Quest - 1:1 Consulting

In collaboration with the Western Dairyland Women's Business Center, CCP staff received funding through the State of Wisconsin Department of Workforce Development and the Wisconsin Community Action Program Association, Inc (WISCAP) to provide one-on-one customized, business technical asssitance with childcare entrepreneurs to start or expand their child care business.

The CACFP is a federally funded program sponsored by the USDA. Licensed or certified family child care providers who participate are eligible to receive financial reimbursement for serving nutritious snacks & meals to enrolled children.

Family Resource Center (FRC)

In 2023, Child Care Partnership launched family support services for Buffalo and Pepin County.

Family Resource Center Infrastructure Grant

CCP received a grant from the WI Child Abuse & Neglect Prevention Board to create a uniform structure and standards that support the provision of effective, quality primary prevention services to families and children (birth to five years) and promote the well-being of children and families while reducing child abuse and neglect.

Staff has received over 100 hours of professional development to offer parent education courses - such as Triple P (Positive Parenting Program)!

Play groups in Buffalo & Pepin Counties will start in spring 2024!

FRC Resource Navigator Homelessness Grant

CCP's Family Resource Navigator worked with the school districts in Mondovi, Durand, and Cochrane-Fountain City to support children and their families that are experiencing homelessness and connect them to community resources and support. Additionally, families have been provided concrete supports - such as clothing, food and household items.

Partner Up!



Partner Up's Cohort 3 kicked off in spring 2023, accepting applications from new businesses wanting to participate, as well as currently awarded businesses looking to renew.

Dream Up!

Dream-Up Grants were awarded to 4 different communities in the Western Region. Staff at CCP worked closely with each team to provide information on current child care trends, strategies to disperse funds, and ways in which to involve other community programs. Two of the core groups have created Child Care Task Forces and are continuously working on strategies to strengthen the child care workforce in the Western Region. **\$21,750.00** was given directly to child care programs in the Chippewa Valley that could be used for employee wages, bonuses, or improvements to the center.

St. Croix Valley:

CCP supported 4 mentors who worked with 8 potential home based family child care providers guiding them through the process of opening their program and navigating the childcare system. This work was vital in supporting the creation of 16 slots!

Chippewa Valley:

CCP spoke at 4 community events, supported a local networking group and collaborated on providing existing programs with retention stipends and social-emotional kits.CCP actively participates in meetings with the task force providing information and insight on child care.

Jackson County:

CCP actively participates in meetings with the Jackson County Child Care Network and provides information and insight on child care in the County. CCP promoted their Art Gala which was a fundraising event to build financial support for child care programs & teachers in Jackson County.

Osseo-Fairchild:

CCP staff supported the lead in recruiting members for the cohort & gaining community attention. Staff assisted in the search for a fiscal agency and the Cohort was able to utilize funds to improve their programs, provide staff bonuses and pay increases, and assist with the start-up of a family child care program, which added 8 child care slots to the area.

Advocacy Efforts

This year was full of opportunities to advocate for the early childhood field and for children and families in Wisconsin.

CCP is a strong voice on child care issues in western Wisconsin. All families should have access to high-quality and affordable child care. With that in mind, CCP staff work to strengthen local task forces, elevate the voices of families, and build information-sharing relationships with key state leaders. In 2023, we worked to develop policy recommendations around new draft bills affecting the child care workforce. These bills work to increase the supply of child care, improve the quality of child care service delivery, and strengthen the early childhood education workforce. We value the relationships CCP staff have built with state leaders!

Data plays a vital role when advocating. Combining numbers and child care stories can lead to positive outcomes. In the fall of 2023, CCP staff initiated a statewide capacity survey. The goal was to better understand Wisconsin's child care climate from a statewide perspective. The data was collected from regulated group centers in Wisconsin. The results from the survey were compiled to create an infographic that was shared widely. Survey results from the statewide survey and our local report are included at the end of this report.

Impacts of this advocacy included:

- Expanded funding for Child Care Resource & Referral agencies to continue to provide local support to families, child care programs and communities
- Expansion of funding for Family Resource Centers across Wisconsin as well as funding for Triple P training across the State
